8.1. APPROVE PURCHASE OF RAVE4 FROM FREEWAY TOYOTA OF HANFORD:: (Angie Dow):

This item is being added to the Agenda as an urgency item. Orders for the 2021 models must be placed by August 10, 2021.

With Board approval, staff submitted an Alternative Vehicle Grant Application to the San Joaquin Valley Air Pollution Control District. This grant provides \$20,000 toward the purchase of an approved alternative fuel vehicle.

KCAPTA received the funding agreement and reached out to our vendor to purchase the approved vehicle. We received notification that the 2021 Rave4 was not available, and we would need to wait until 2022 models were available.

Kings County was also awarded funds through the San Joaquin Valley Air Pollution Control District for Rav4's. Kings County Public Works and Freeway Toyota of Hanford can add our vehicle to their order, but the vehicle must be ordered before August 10, 2021.

The cost of the vehicle is \$37,142.75 plus tax.

Recommendation

Staff is recommending the Board approve the purchase of the RAV4 from Freeway Toyota of Hanford and authorized the Executive Director to work with Public Works to add the vehicle to their existing order.
