The Public hearing was opened at 2:03 pm to hear testimony from the public. A copy of the email is included in the agenda packet, and it was read by Mark Pedreiro, Transit Manager at KCAPTA. A second comment was received in writing and read by Mark Pedreiro from Luis Castaneda who was present at the meeting but requested his testimony be read by Mark Pedreiro, who requested a bus to go to Madera Children's Hospital. No more comments were received. Close Public Hearing-End of Comments at 2:07 pm. Kings County Association of Governments (KCAG) has two more public hearings in April and May. KCPATA will present findings in the June 2023 Board Meeting.

5. APPROVE RESOLUTION 23-05 AUTHORIZING THE FILING AND EXECUTION OF LOW OR NO EMISSION GRANT AND THE BUS & BUS FACILITY GRANT (Angie Dow):

Resolution 23-05 authorizes Staff to apply for a grants under the FTA 5339 (c) 2023 Low or No-Emission Grant Program and 5339 (b) Bus & Bus Facility Grant Program in the amount of \$15,000,000 for the Electrical Infrastructure for Charging All-Electric Buses Project.

The proposed project would upgrade KCAPTA Maintenance Facility at 629 Davis Street to prepare to charge a fleet of 100% zero-emission buses (ZEBs).

Board Approved Resolution 23-05 authorizing the Executive Director to submit the applications for FTA Section 5339 (c) and Section 5339 (b)

6. Approve 3-Month On-Demand Pilot Project in the City of Avenal (Angie Dow):

The City of Avenal has contacted KCAPTA and requested additional transit services in the City of Avenal. Their request is based on the recent completion of a Resource Center in Avenal. Also, the City has had discussions with other social service centers and their transportation needs.

If approved, the pilot would begin in April and end in June. The operational hours would be Monday – Friday from 7:00 am to 4:00 pm. During the pilot period, operation hours may be modified based on demand.

Staff and the City of Avenal will meet bi-weekly to discuss performance, issues, and develop and monitor performance standards.

Prior to the end of the pilot, staff will recommend to the Board if the service should continue or suggest alternatives.

7. HANFORD "UBER SERVICE" UPDATE (Angie Dow)

KCAPTA's contract with Uber will expire in June of 2023. Uber has notified KCAPTA that they are eliminating the Uber Transit Option and will not renew contracts. KCAPTA would have the ability to use vouchers and use uber drivers if we wanted to continue with them.

The Ecolane App is currently used in Lemoore's On-Demand Service and our Paratransit Service. Once the ability to pay via the App has been set up and tested. KCAPTA will begin the transition of Hanford "Uber App" users to the new Ecolane App. We might extend UBER service because we might need it as an alternative to transportation pockets that KART is not able to serve such as West Hills College needing transportation after KART hours. KART can issue a \$5.00 voucher Uber gets paid \$3 the rider pays the difference as an example.

KCAPTA Staff:

Angie, Executive Director:

- 1. Working with the City of Hanford to issued the permits for the construction project. We must award the construction project by July 19th, because of the funding sources have to be obligated. But everything is going on schedule as of now, anticipating to come to the board to award in June 2023. If everything is ready before June, KCAPTA might call a special meeting around June 8th or 9th to award before her vacation in June 2023. David Orth will not be available on the 8th. It has an 18-month cycle, Hanford Routes have been re-designed, then surplus property, remove homeless from transit has been a problem because AMTRAK has remove their shelters and so now homeless are moving into our transit area. KCAPTA is working with Police to help with the problem. KCAPTA is trying other solutions but will see in the future if needs to hire private security to check the station late at night when not operating.
