4. APPROVE KCAPTA 2024 BOARD MEETING CALENDAR (DATE AND TIME) (Angie Dow/Maria Ortiz):

Kings County Area Public Transit Agency (KCAPTA) is a Joint Power Agency that was established in July of 1979. Article II, Section 3: Meetings states "The Board shall hold regular monthly meetings and shall establish a date, time, and place for those meetings". In 2007, Amendment 5 amended this Section to "The Board shall hold regular meetings at least every three months and shall establish a date, time and place for those meetings".

Historically KCAPTA regular meetings are held every 4th Wednesday of the month at the Kings County Board of Supervisors Chambers at 3:30 PM. Due to the Kings County Board of Supervisors Chambers extensive remodel, KCAPTA has been holding are meeting at the City of Hanford Council Chambers.

Staff is proposing the KCAPTA's 2024 regular meeting continue to be held every 4th Wednesday of each month at the Kings County Board of Supervisors Chambers at 2:00 PM.

Until the Board of Supervisors Chambers remodel is completed, we will continue to hold Special Meeting **Place** at the City of Hanford Council Chambers. Per our discussion with the County, they estimate the remodel will be completed by February 2024.

5. APPROVE FIXED ROUTE DECEMBER 2023 FREE TRANSIT WEEKS (Heather Corder):

KCAPTA 22/2023 LCTOP projects were approved. The Low Carbon Transit Operations Program (LCTOP) is part of the Transit, Affordable Housing, and Sustainable Communities Program established in 2014. It was created to provide operating and capital assistance for transit agencies to reduce greenhouse gas emissions and improve mobility, prioritizing serving disadvantaged communities.

KCAPTA proposed two projects Free Transit and Reduced Fares, which were approved on November 15, 2023, and staff is recommending the Board approve free Fixed Route service from December 18, 2023 – December 30, 2023. If funds remain in the project staff will propose additional dates/weeks at our January 2024 Board meeting.

KCAPTA Reduce Fare project implementation recommendations will also be included in our January 2024 Board meeting.

Recommendation

Staff recommends the board approve free Fixed Route Service from December 18, 2023 – December 30, 2023.

6. APPROVE CAPITAL PURCHASE OF A GENFARE FAST FARE TEST BENCH (Mark Pedreiro)

Staff is recommending the purchase of a Fast-Fare Test Bench from Genfare. The test bench is used to read, diagnose, and repair a faulty Fast-Fare Farebox.

The Fast-Fare Farebox is Genfare's all-in-one, customizable farebox that quickly accepts, validates, and processes whatever form of payment is in the rider's pocket while collecting valuable data in real time.

The total cost of the Test Bench is \$20,170.77 and would be funded with STA Funds and will require the Board to approve the related budget amendment.

Recommendation

Staff recommends the Board approve the purchase of the Fast-Fare Test Bench from Genfare, approve the related Budget Amendment, and authorize the Executive Director to issue a purchase order in an amount not to exceed \$20,177.77
