**IN THE MATTER OF UPDATING OF KINGS COUNTY AREA PUBLIC TRANSIT AGENCY 2025 TITLE VI PROGRAM  
COMPLIANCE PROGRAM**

**WHEREAS**, Title VI of the Federal Civil Right act of 1964 states that: No person in the United States shall, on the ground of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance; and

**WHEREAS**, Kings County Area Public Transit Agency (KCAPTA) receives federal funds to provide public transportation to Kings County; and

**WHEREAS**, as a recipient of federal transportation funds, KCAPTA is required to comply with Title VI of the Civil Rights Act of 1964, including provisions detailed in U.S. Department of Transportation's FTA Circular 4702.1B, Title VI Requirements and Guidelines for Federal Transit Administration Recipients and the California Department of Transportation ("CalTrans") regulations; and

**WHEREAS**, the Kings County Area Public Transit Agency Board previously approved KCAPTA's Title VI compliance Program on March 23, 2022; and

**WHEREAS**, to remain in compliance with the above agencies' regulations, KCAPTA has updated its Title VI Compliance Program, covering the period 2025 through 2028, and which will be submitted to the appropriate state and federal agencies; and

**WHEREAS**, the Kings County Area Public Transit Agency Board desires to approve the updated Title VI Compliance Program to comply with the Federal Transportation Act and CalTrans requirements and to authorize the Executive Director to submit the Program to the appropriate state or federal agencies.

**NOW, THEREFORE, BE IT RESOLVED:**

By the Board of Directors of the Kings County Area Public Transit Agency approves its 2025 – 2028 Title VI Program.
