WHEREAS, Kings County Area Public Transit Agency (KCAPTA) receives federal funds to provide public transportation to Kings County; and

WHEREAS, as a recipient of federal transportation funds, KCAPTA is required to comply with Title VI of the Civil Rights Act of 1964, including provisions detailed in U.S. Department of Transportation's FTA Circular 4702.1B, Title VI Requirements and Guidelines for Federal Transit Administration Recipients and the California Department of Transportation ("CalTrans") regulations; and

WHEREAS, the Kings County Area Public Transit Agency Board previously approved KCAPTA's Title VI compliance Program on March 23, 2022; and

WHEREAS, to remain in compliance with the above agencies' regulations, KCAPTA has updated its Title VI Compliance Program, covering the period 2025 through 2028, and which will be submitted to the appropriate state and federal agencies; and

WHEREAS, the Kings County Area Public Transit Agency Board desires to approve the updated Title VI Compliance Program to comply with the Federal Transportation Act and CalTrans requirements and to authorize the Executive Director to submit the Program to the appropriate state or federal agencies.
