AMENDMENT 02 TO AGREEMENT 25-J-01-00

Amendment 02 to Agreement (25-J-01-00) Between San Joaquin Joint Powers Authority and Kings County Area Public Transit Agency for Thruway Bus Service Between Hanford and Visalia

This Amendment 02 ("Amendment"), with an effective date of July 01, 2026, is entered into by and between San Joaquin Joint Powers Authority ("SJJPA"), a joint powers authority and Kings County Area Public Transit Agency ("KCAPTA") doing business as Kings Area Regional Transit ("KART"). SJRRC and KART are sometimes individually referred to as a "Party" or collectively referred to herein as the "Parties."

WHEREAS, SJJPA and KART entered into a Non-Binding Memorandum of Understanding for Thruway Bus Services Between Hanford and Visalia dated July 01, 2024, SJRRC contract number 25-J-01-00 (together with all amendments, supplements and properly executed modifications, the "MOU")

WHEREAS, on July 01, 2025, the Parties executed the first amendment to the MOU to extend the term of the MOU through Fiscal Year 2025/2026 (July 01, 2025 – June 30, 2026); and

WHEREAS, SJJPA requested, and KART agrees, to extend the MOU through Fiscal Year 2026/2027 (July 01, 2026 – June 30, 2026); and

WHEREAS, the Parties agree that a first amendment to the MOU is advisable to continue through Fiscal Year 2026/2027; and

NOW, THEREFORE, parties agree as follows:

1. Pursuant to Section 2.05 shall be deleted in its entirety and replaced by the following:

The Hanford to Visalia Connector (Kings/Tulare) will be funded by SJJPA in an amount not to exceed of \$115,000 for Fiscal Year 2024/2025, and \$75,000 for Fiscal Year 2025/2026, **\$75,000 for Fiscal Year 2026/2027 (July 01 – June 30)**. There is no end date to this MOU, but the amount payable for the Service is subjected to annual appropriation by the state. Therefore, SJJPA has the ability to increase the amount as operation costs can increase over the years. Any change to the not to exceed amount must be agreed to by the Parties in writing.

1. This Amendment may be executed in any number of counterparts, each of which when so executed and delivered shall be deemed an original for all purposes, and all such counterparts shall together constitute but one and the same instrument. A signed copy of this Amendment delivered by email shall be deemed to have the same legal effect as delivery of an original signed copy of this Amendment.
2. Except as amended herein, the terms and conditions of the Agreement remain in effect. Capitalized terms not defined herein have the same meaning as set forth in the Agreement.

IN WITNESS WHEREOF, and in acknowledgement that the Parties hereto have read and understand each and every provision hereof, the parties have caused this Amendment to be executed on the date first written above.
