AMENDMENT 01 TO AGREEMENT #26-06 WITH LEMOORE COLLEGE

**AMENDMENT No. 1 TO
AGREEMENT # 26-06**

FOR TRANSIT SERVICES

**BETWEEN THE KINGS COUNTY AREA PUBLIC TRANSIT
AGENCY (KCAPTA)
AND WEST HILLS COMMUNITY COLLEGE DISTRICT**

This Amendment No. 1 ("Amendment") is made and entered into this 26th day of August 2026, by and between the Kings County Area Public Transit Agency ("KCAPTA") and West Hills Community College District on behalf of Lemoore College ("Lemoore College")

RECITALS

WHEREAS, KCAPTA and Lemoore College entered into Agreement #26-06, executed March 25, 2026, for KCAPTA to provide fixed-route transit services to eligible Lemoore College Students;

WHEREAS, the Agreement provides that eligible students can receive rides at no cost upon presentation of a valid student identification card;

WHEREAS, Lemoore College now desires to extend eligibility to include College staff under the same service structure; and

WHEREAS, both Parties wish to amend the Agreement accordingly while preserving all other terms, conditions, and obligations.

NOW, THEREFORE, the parties hereby agree to amend the Agreement as follows:

1. **Amendment to the "SERVICES" Section**

The section titled **SERVICES** shall be amended to read:

SERVICES. KCAPTA shall provide fixed route services to eligible Lemoore College students and staff.

Eligible students and staff shall receive rides at no cost at the time of boarding upon presentation of a valid Lemoore College identification card.

Services provided under this Agreement apply to KCAPTA's fixed route system, and Eligible riders may ride any fixed route within the KCAPTA system.

2. **Amendment to the "Eligibility and Verification" Section**

The **ELIGIBILITY AND VERIFICATION** section shall be amended to include:

ELIGIBILITY AND VERIFICATION. Lemoore College Staff must present a valid Lemoore College staff identification card at the time of boarding.

Lemoore College will provide KCAPTA with a copy of the eligible staff identification card.

KCAPTA shall verify eligibility at the time of service and shall track all eligible student and staff boarding provided under this Agreement.

3. **Amendment to "Tracking and Reporting" Section**

The **TRACKING AND REPORTING** section shall be amended to include:

TRACKING AND REPORTING. KCAPTA shall maintain records of all Lemoore College rides provided under this Agreement, regardless of the route utilized.

4. **Payment Provisions**

The existing per-ride payment structure and the Agreement's not-to-exceed amount of \$100,000 shall apply to both students and staff.

If combined student and staff ridership causes the total compensation to reach \$90,000, the Parties shall revisit the Agreement to determine whether an adjustment to the not-to-exceed amount is needed. Any adjustment must be made through written amendment.

5. **No Other Changes**

Except as expressly modified by this Amendment, all terms, conditions, and provisions of Agreement #26-06 shall remain in full force and effect.

6. **Effective Date**

This Amendment shall be retroactive to the original agreement date of 08/01/2026.
